From: Mary Shaver - January 4, 2011 at 9:51am Subject: MARK YOUR CALENDARS! 2011 Ohio Lobby Day for Companion Animals! Dear Companion Animal Lovers ~

Please join advocates from across the state for the Ohio Companion Animal Lobby Day in Columbus on Wednesday, April 6 from 10-2 PM!

We will be hitting the halls of the state capitol to advocate for bills and ballot initiatives to address issues impacting the welfare of companion animals that are occurring right here in Ohio. The day will be action packed – a briefing, lobbying, and a press conference, all of which will provide the perfect opportunity for us to urge state legislators to recognize animal cruelty, dog auctions, puppy mills and breed-specific legislation as serious issues, and take action to effectively address them in Ohio. And - you don't need to be an expert in lobbying to take part!

There are many new legislators in Ohio as well as incumbents, who do not yet know that Ohio is only one of four states which do not have a subsequent-offense or first offense felony animal cruelty law and has enacted statewide breed-specific legislation. And many may not be aware that Ohio has the only dog auction east of the Mississippi which attracts buyers and sellers from 15 states, many of whom have long standing, repeated violations of the Animal Welfare Act or have been convicted of animal cruelty.

Face to face meetings are one of the best ways to ensure that legislators hear your message and take action - and you don't need to be an expert or have any experience in lobbying to take part! We will provide you with everything you need! For just a few hours of your time, you can make a tremendous difference. So please grab a friend and join us! All Ohio residents are invited!

PREVIEW OF LEGISLATION THAT DID NOT PASS IN THE 128TH GENERAL ASSEMBLY, WHICH WILL BE INCLUDED ON OHIO COMPANION ANIMAL LOBBY DAY!

 HB 55 - To amend sections 955.11, 959.99, 2152.19, 2903.213, 2903.214, 2919.26, 3113.31, 4732.141, and 4757.33 and to enact section 4731.284 of the Revised Code to revise the penalties and sentencing provisions regarding violations of the cruelty to animals statutes, to include the protection of companion animals in temporary protection orders, domestic violence protection orders, anti-stalking protection orders, and related protection orders, and to remove pit bulls from the definition of "vicious dog" in state law

2. HB 70 - To amend sections 959.131 and 959.99 of the Revised Code to specifically prohibit an owner of a kennel of dogs from committing cruel treatment of a companion animal by the animal's custodian or caretaker and to give a prosecutor who prosecutes an owner of a kennel of dogs who commits cruel treatment of a companion animal discretion in prosecuting the owner for the offense.

3. HB 79 - To amend section 955.11 of the Revised Code to remove pit bulls from the definition of "vicious dog" in state law.

4. HB 175 - To amend sections 109.73, 317.08, 959.131, 1717.01, 1717.04, 1717.06, and 1717.09 of the Revised Code to require a person to file proof of successful completion of training with the county recorder prior to being appointed as a humane society agent and to require the revocation of an appointment under certain circumstances.

5. HB 570 - To amend sections 955.04, 955.21, and 955.99 and to enact sections 956.01 to 956.11 and 956.99 of the Revised Code to establish standards of care for commercial dog breeding kennels and to establish requirements governing the sale of dogs.

## AKC Welcomes Three New Breeds

The American Kennel Club is pleased to announce that three new breeds became eligible for AKC registration on January 1, 2011, bringing the totally number of registered breeds to 170.



The Entlebucher Mountain Dog was bred to move cows from pasture to pasture in the Swiss Alps. Medium-sized and strongly muscled, the Entle is a hard worker and can excel at canine sports.



The Norwegian Lundehund is the only AKC-registered breed whose original purpose was puffin hunting. Today the breed makes a loyal and playful family companion.



One of the world's oldest and rarest breeds, the Xoloitzcuintli are still considered "healers" in remote Mexican and Central American villages today. The breed's name is pronounced show-low-etz-queent-lee.

The AKC also welcomes the following breeds into the Miscellaneous Class: Bergamasco, Boerboel, Dogo Argentino, Portuguese Podengo Pequeno, Peruvian Inca Orchid, Pumi, Sloughi and Wirehaired Vizsla.
