## **IMPORTANT - PLEASE READ!**

COURSE MAPS WILL BE POSTED AS PER AKC. It is recommended that exhibitors take a photo with their phone or tablet. Course maps will be emailed to exhibitors the morning of each day of trial. If you cannot take a picture with your phone or don't have a printer at home, please see the trial secretary or someone at scoring table.

Exhibitors will need to move their dogs in the running order as it's not edited to space out Handlers with multiple dogs. Please feel free to ask for help if needed.

## **Directions to show site:**

Building is right across from blue water tower.

From South: Take I-77 or I-71 North toward Cleveland. Exit onto I-76 East toward Akron. Take I-80 toward Youngstown and NYC. Exit onto Bailey Road, turn right. Turn right onto Mahoning Avenue at the light.

From East or West: Take the Turnpike and Exit at Interchange 218. Take I-80 East to Bailey Road, Exit onto Bailey Road, turn right. Turn right onto Mahoning Avenue at the light.

From North: Take 11 South to I-80 West. Exit on Bailey Road, turn left. Turn right onto Mahoning Avenue at the light.

## **Set up:**

You may set up crating and/or tents beginning Thursday, October 2<sup>nd</sup>, 2025 from 4:00-5:00PM.

**First dog on the line at 9 am on Friday and 8 am on Sat and Sun.**

The building will be open an hour prior each day.

Inside crating will be marked with tape. Each dog will have about a 3' X 4' space. Mats under all crates, please.

No dogs left on-site after show hours.

You are welcome to bring a tent and crate outside or crate from your car.

## **Motels:**

#### **Show Conditions:**

**Indoors on rubber matting over a 5/8" foam sports cushion. Ring size is 85' X 100'. Contacts have rubberized surface. The site is now air conditioned, it has two very large ceiling fans, an air movement system and air purifier system. Electronic timers will be used. We have 8 beautiful acres to spread out for walking (or crating if you prefer outside) to the right and left of the building. The left side has some trees, is closest to the building and has no parking lot to pass through. Right side is a big grassy**

area, but you must cross the stone driveway to enter the building. Please avoid the back of the building as we hope not to contaminate the area prior to our scent trials. There will be 3 pick-up bag stations available on the exterior of the building at the front and both sides for your convenience.
